1 Prayers

The Meeting commenced with Rev Mark Ansell leading the Committee in prayer.

2 Apologies

Councillor Keith Evans, Keith Henson, Ceris Jones together with Mrs Alwen Roberts and Professor Catrin Williams apologised for their inability to attend the meeting.

The Chair welcomed to the meeting Mrs Rhiannydd James, School Support Advisor who would be attending the meeting on behalf of Mrs Mary Davies who was currently unwell, and all wished her well on a speedy recovery. Best wishes were also extended to Councillor John Roberts who was in hospital, and all extended their deepest condolences to him and his family on the death of his granddaughter.

3 To confirm the Minutes of the Meeting held on 05 July 2023 and to consider any matters arising from those Minutes

It was AGREED to confirm as a true record the Minutes of the Meeting of the Standing Advisory Council held on 05 July 2023 subject to
(i)amending the surname of Rev Aled Davies to Jones and that he was representing The Union of Welsh Independents and not The Presbyterian Church of Wales as recorded;

- (ii) amending the name of Guto Gwynfor to Guto Prys ap Gwynfor and that he was representing The Union of Welsh Independents and not The Presbyterian Church of Wales as recorded; and
- (iii) confirming that Mrs Laurie Hughes, Wellbeing Advisory Teacher would be providing further presentations to the Committee, as the information provided had two additional elements to consider

Matters arising

Forward Work Programme – It was reported that Miss Nia Wyn Jones would attend the summer term meeting as there would be less focus on exam preparation.

4 Membership

An update was provided on the membership of the committee. Following discussion, it was AGREED that:-

- (i) the School Support Advisor would contact Mrs Medi James to confirm her position in relation to becoming a member of the Committee,
- (ii) that Mrs Manon Lewis, Head of School of Education, Aberystwyth University would be approached to join the committee as a co-opted Member,
- (iii) that Mr Colin Patridge be contacted to attend the next meeting, as the School Support Advisor was unsure if an invite had been sent to him prior to this meeting

5 Religion, Values and Ethics

The Chair welcomed to the meeting Mr Aled Rumble to make a presentation on - Religion, Values and Ethics. The following information was outlined:-

Following discussion on the content of the presentation, it was AGREED to note the current position and that pupils would be provided with information on after school clubs provided by various religious denominations that were available to assist them to become moral citizens.

6 Update on the numbers studying RE

It was reported that the numbers were the same as provided at the previous meeting. The official figures would be available after December. It was also reported that the figures studying in the new term could fluctuate as pupils had up to October half term to decide if they wished to pursue studying the subject.

Concerns were raised on the number of teachers that would be studying RE in the future and the courses available, it was reported that Mrs Manon Lewis could assist if she attended the next meeting to facilitate the discussion on this, together with Professor Catrin Williams. It was reported that there were already several examples of good practice of resources that could assist teachers, such as the Peace Assembly and Philosophy/RE Department in Cardiff University and the opinion of atheists should also be considered. It was reported that regular seminars were held to assist new teachers in this subject.
