The vaccination programme continues to be successful and is on track to reach its target to complete first dose vaccinations for those over 50 years of age by 12th April.

School pupils are continuing to return to school. This week, pupils from years 4,5 and 6 are returning to primary schools and years 11,12 and 13 are returning to secondary schools. Year 10 pupils will be returning next week. Years 7, 8 and 9 will return after the Easter holiday with well-being visits being offered before the Easter break.

No positive tests have been recorded from residents in the county's care homes during the last month. Family visits can take place at care homes from 1st April in the visitor pods provided.
