I have been running the family farm at Synod Uchaf for almost 20 years. In the past it was a mixed farm but I only farm beef cattle now. TB has not been a problem for me, although the farm is tested occasionally due to neighbours having had positive TB tests. If we were to have a positive test, it wouldn't change much in the way I farm, nor affect my income because I fatten the cattle and sell them on the hook rather than in the livestock market where a clear TB test is required before going to the mart.

Nevertheless, since the Notice of Motion deals directly with TB, I must be transparent and go through the correct processes and ask for dispensation on this matter.

Since Ceredigion is a rural county, agriculture is its main industry. Farmers have suffered terribly over the years because of TB in cattle and wild animals. It is a bad disease whereby hundreds of thousands of basically healthy cattle are culled, regardless of the age of the animal, and in the case of a rearing cow, the unborn calf dies in the womb.

As a councillor and by now leader of Ceredigion County Council, I have electors in my ward and county who have suffered, or are suffering, from the effects of TB on their income and even worse, on their mental health. The endless testing puts a serious strain on the cattle and there are numerous cases of farmers/staff who have been injured or even killed by an animal that has become enraged whilst getting tested under these conditions.

As i stated in an answer above, TB does not excessively affect my income nor the way I farm, but as a councillor and leader I must speak up for those people I represent. The accidents and cases of suicide in the agriculture industry because of the endless testing for TB is a cause of great concern for me. By putting this notice of motion before the council I hope we can persuade the Welsh Government to review their approach to preventing or reducing the cases of TB in rural Wales.

I kindly ask you as a Committee to consider my application so that I may speak and vote on this important matter.

If I am fortunate enough to come before you as a Committee, I am more than happy to try and answer any questions or comments that you may have.
