I think the committee should grant dispensation to speak and vote on this motion as it is a hot topic in the rural area we live in, and has a negative impact on farm businesses, the wellbeing and mental health of farmers, and also the stress and worrying about TB affects them financially. When discussing a topic like this I think it's important to have a cross-section in the discussion, and it's extremely important to get the views / knowledge of individuals who have connections in the agriculture industry, to get the full picture about the seriousness of the situation. We must also be able to support farmers within our wards as best we can by representing them effectively at a full council meeting.

TB has long been a problem in rural areas and for farmers. It has a huge impact on their financial and mental situation and how they go about their daily life. It is a subject that troubles many farmers within my elected area and it is my duty to represent them.

I understand that the Welsh Government want to consider the way they are dealing with the situation currently and I think it's a perfect opportunity for us as a Council, with a cross-section of knowledge and experiences, to inform this strategy.

Making use of the knowledge of individuals who have experienced this – in my case family members who struggle every year with all the guidance and testing – is very beneficial for the full council so it has a cross-section of information to make productive recommendations to the Government, for the better.
